District Councillors Report January 2022

I hope you have all had a decent festive season and ready for another fun packed year.

The District Council continues to monitor Covid related sickness but with a few changes and staff movements, continues to offer all of its services, including the refuse collection service, vital to Cocking and other rural locations.

Booster vaccination have reached a high level in the north part of the District. Free transport is available to vaccination centres is available. The NHS transport co-ordination team can be contacted on 01444 275008 or by emailing vaccinations@sussexct.org.uk

CDC has received a letter from the Environment Agency thanking the council for the excellent work that it is doing to help reduce the risk of flooding to the communities across the area. The Environment Agency is seeing difficulties of continuing to deliver capital works in the face of Covid, but they stated that CDC continues to find ways to deliver excellent results. As a council they are spending £300,000 this year alone to help the Environment Agency reduce the risk of flooding to over 5,000 homes across Sussex and Hampshire over the next six years.

The Government has informed CDC that it will allocate £2.8 million to distribute in rates relief to those businesses who did not qualify for Extended Retail Relief, for example factories or offices.

CDC has introduced a scheme to help keep people warm and well called the Chichester Warm Homes Initiative. This scheme is for residents on low income

living in a property with poor energy efficiency. It can contribute towards the installation of an efficient heating system, as well as loft and wall insulation. Avian flu is causing concern. In response to the heightened risk of H5N8 highly pathogenic avian influenza, APHA (Animal & Plant Health Agency) advised near the start of November that an Avian Influenza Prevention Zone (AIPZ) had been declared in England (Scotland and Wales). This introduced additional biosecurity measures for all poultry and captive bird keepers to protect them from the risk from wild birds e.g. all birds should be kept housed. The measures apply to all poultry keepers (including game) whether you keep birds commercially or as pets. Further details, including the measures that apply in the AIPZ, can be found at GOV.UK:
