Dis Cllr Gordon Gordon Macara had circulated a report prior to the meeting and added that: CDC binmen would be striking after Christmas; CDC had written to all social landlords in the district about mould in homes, following the tragic case in Rochdale.

8. Highways Updates

- a. Footpaths & Footways a footpath that links Church Lane to Bumblekite needs gravel in two places where it is muddy and slippery.
- **b.** Cycleways as per last meeting. This scheme would not detract from a proposed extension of the Centurion Way which was currently now a long way off.

9. Updates on Parish Matters

- a. Playground Contractors were looking at replacing part of the fence. A picnic table inside the fence needs replacing, approx. cost £150.
- b. Village Hall Cllr Imlach reported on plans to replace a rear fire door. Clerk to chase Broadband quote.
- c. Benches sagging bench at the playground was still to be renovated, ditto the seat at Crypt Lane.
- d. First Aid Training had taken place. Fully subscribed and well received.
- e. Bus Shelter at play area looking tired.

10. Finance

- a. Payments since last meeting were **RESOLVED** and any receipts NOTED Appendix A.
- b. Bank Reconciliation to 14 November 2022 was **RESOLVED** Appendix **B** and the bank statement was subsequently initialled by the Chairman.
- c. Members reviewed the draft 2023-24 budget to be confirmed in January. Traffic calming continues to be the number one concern raised with the Parish Council. To this end it has been trying to progress the installation of a Speed Indicator Device (SID) to the north of the village. The cost to supply and install is £5,923. The Parish Council currently takes £13,567 from residents and has so for the last 3 years. This project, for which no grants are likely to available, would nearly deplete the Council's reserves, so if the Council were to undertake this is in 2023-24, it would need to add this project to the council tax. Mindful of the current burden on households, **RESOLVED** to ask residents their views on increasing council tax to pay for this item. It would add £27.22 to a typical Band D property in the parish which is an increase of 43.66% on the parish element. Clerk to provide suggested wording to Cllr Cornwell for inclusion in next Cocking Column.

11. Any Other Matters for Information

Cllr Imlach reported that he had attended a meeting about Pendean Quarry recently - a new planning application was to follow.

It was reported that the editors of the Cocking Column e-newsletter were standing down.

It was reported that a complaint had resulted in feather banners promoting a local business being removed.
